## PREPARATION OF THE GROUPS

All participating countries will have to provide a presentation regarding Human Rights in their countries. The presentation must be prepared by the group of participants of each country and it must not exceed the 15 minutes session. You can use your own template or the one that E.O. SHARP MINDS will send you, together with the categories of interest, so you can focus on specifics during your research.

Keep in mind that E.O. SHARP MINDS provides the space for new ideas to flourish. The participants of each group will be assigned with specific roles and tasks during the project so we can achieve the needed active participation for all.

We highly encourage a polite and respectful attitude during the whole project. The participants are required to have the willingness to explore and learn. There will be a very demanding and challenging Training Course which includes various methods of learning.

Additionally, inside the frame of the Environmental Sustainability and personal responsibility, we will try to limit our meat and dairy consumption due to European Guidelines for combating the climate crisis. Additionally, inside the Hostel you will find different boxes where we will collect and recycle glass, plastic and paper. It's not enough to declare that we concern about the environment but in every chance we got, we must also prove it!!

## Participants and their profile standards

The Training Course will accept participants from 18-40 years old, under the term that at least the 80% of the total number will not be more than 30 years old.

The groups must be gender balanced and at least the 50% of the participants must be people with less opportunities (social, educational, economical, geographical). In this way we offer the chance for more people to experience the Erasmus+ Program without leaving any obstacle to block their life opportunities.

The selection and the preparation of the participants will be done under the responsibility and guidance of the Partner Organizations, respecting the requirements of the project as they are described inside the current InfoPack.

It is strongly advised for the participants to have good knowledge (both reading and writing) of English language since it is the official language of the TC and terminology sessions will take place during the activities.

## Vaccination Requirements and Covid-19 restrictions

All participants are required to have a valid European Certificate of Vaccination or a valid Certificate of Recovery from Covid-19, according to the regulations issued by the Greek Government and the Greek Ministry of Health.

It's very important to keep in mind that all certificates have to be valid at least until the end of the Project (7th of April, 2022).

We strongly recommend that participants should complete their vaccination including "boost dose".

## Insurance policy - Security

All participants are strongly suggested to issue the European Card of Insurance. This card is possible to be issued only by the participants from EU countries. For participants out EU, we strongly advice to have a private health insurance plan.

Educational Organization SHARP MINDS, keeping the security standards, has booked the whole Hostel during the whole project, FOR EXCLUSIVE USE OF THE PARTICIPANTS. In this way we reassure the security, inside the Hostel, of our participants 100% . Additionally, there will be personal lockers where any of the participants can secure their stuff.

## Accommodation in ICONIC ATHENS HOSTEL

The Hostel is located in the area of Kerameikos (Gazi), one of the most vivid areas in Athens. It is only 150m away from Metro Station Kerameikos and the area is absolutely safe.

All rooms have internal bathroom/s. Towels will be provided in everyday base and the sheets will be changed every week. Both training and meals will be implemented in the Hostel Lobby.

Any dietary restrictions will be handle by E.O. Sharp Minds and the 2 Chefs that they will cook and prepare the meals for the project. The Chefs will be students - volunteers of the Vocational Training Institute of Acharnes.

All tickets will be reimbursed according to the traveling budget limits defined by Erasmus+ Distance Calculator (as shown above).

For the reimbursement of the travel expenses, EO SHARP MINDS **must have in original or digital form**, the tickets used as much as the boarding pass of each participant. Any missing traveling document will not be reimbursed. Any fake invoice that doesn't have a QR-Code, will not be reimbursed.

The reimbursement will be done **ONLY** via our Organization's Bank Account directly to the Partner's Organization Bank Account. There will be no case for the transfer to be done in an individual account or to reimburse in cash.

After arriving at Athens International Airport, you must take the Metro line 3 (M3 Blue Line) destination Egaleo. You should stop at the Kerameikos Station. The Hostel is just 1 minute walking distance from Kerameikos Metro Station.
